The law now recognizes that children need the support and involvement of both parents after family breakdown and separation. Thus, Family Law now focuses on cooperation and encourages separated parents to work together to make arrangements in the best interests of their child/ren.

If unable to agree parents must attend Family Dispute Resolution (unless a legal exemption applies) and make a genuine attempt to settle.

A Parenting Plan is a written agreement that is signed, dated and must be made free from any threat, duress or coercion.

There is also a presumption of shared parental responsibility with the requirement that consideration be given to child/ren spending equal or substantial and significant time with both parents and where it is in their best interest and practicable, children have a right for both parents to participate in all aspects of their lives including weekday, weekend, holiday and special day times.

★ **Family Law Certificates**

Parents (or other persons) cannot go to Court for Parenting Orders unless a certificate has been issued by an Accredited Practitioner (except where a legal exemption applies).

You do not need to be on long waiting lists for up to three (3) months to participate in Family Dispute Resolution and reach an agreement or receive a certificate.

We agree that unresolved family conflict is not in the best interests of children and where it is agreed by the parties we can arrange a Family Dispute Resolution Conference in as little as 24 hours from initial contact.

★ **Solicitor Inclusive Service**
